WITH FULL KNOWLEDGE OF THE ACTIVITIES INVOLVED, I HEREBY ASSUME THE RISKS OF PARTICIPATING IN THESE EVENTS.

By signing this Release of Liability, I am acknowledging that these events, firearms (in general), shooting, handling firearms, shooting competitions, and even being at a shooting range (all collectively referred to as "shooting activities") are hazardous activities and that I am voluntarily assuming the risks of participation in such activities with knowledge of the inherent dangers involved, and hereby agree to accept any and all risks of injury or death associated with such activities. I further acknowledge that these events involve physical and mental challenges, including risks of exposure to weather including extreme heat, sun, cold, precipitation, and other environmental factors, and dangers inherent in the natural environment, and that I understand the risks include but are not limited to dehydration, over-exertion, frostbite, exposure, lightning, snake bites, heat stroke, and other physical dangers including serious injury or death. I understand that these events are extremely physically challenging and I declare that am medically and mentally sound to compete.

I agree that I will not sue, or otherwise make any claim against STEEL SAFARI LLC dba COMPETITION DYNAMICS, a Colorado limited liability company, its owners, its employees or contractors, event staff or volunteers, owners' agents, family members, heirs, successors, assigns, personal representative, or trustees of any trust established by any owner, or the host range owners (herein referred to as *Releasee*) for injury, loss or damages resulting from the negligence or other acts, however caused, by *Releasee* as a result of my participation in shooting activities or any other activities related thereto.

I also hereby agree to release and discharge *Releasee* from all actions, claims or demands, for myself, my heirs and personal representatives, for death, injury, loss or damage resulting in my participation in shooting activities with *Releasee*. The terms of this Release shall also be binding as to any other persons, or members of my family, including any minors, which may accompany me.

I am over the age of eighteen (18) years of age / or my legal guardian has also read, initialed and signed this Release below my signature.

In consideration of being permitted to participate in these events, I grant full permission to COMPETITION DYNAMICS and their agents, associates, as well as any assignee, to use photographs, video, digital media, electronic media, and any other record of the events, including my name, likeness, voice, together with any subject matter owned by me, for any legitimate purpose, without any compensation.
